How the Score is determined:

In each province, we identify 4 key areas of measurement that impact on our rights and freedom as citizens:


- 1.) Public statement of commitment (Politician's Pledge),

A measure of a candidates willingness to respond to a questionnaire that informs constituents regarding their position on important issues facing constituents. A failure to reply indicates resistance to transparency.


Public Advocacy in defense of our Rights and Freedoms
