 Bill 36 - Health Professionals and Occupations Act  <p>The Provincial Government can conduct warrantless searches of medical offices, dictate healthcare services and access private clinical records. Fine doctors \$200,000 or prison up to 6 months for noncompliance, forced mental health assessments for professionals.</p>	Absent
 Bill 44 - Housing Amendment Act  <p>Encourages densification by transferring the authority for issuing building permits from the municipal to the provincial government and removes a homeowner's ability to contest decisions about neighbourhood densification. Developers can make changes remotely.</p>	Voted Against
 Bill 47 – (passed Nov 2024)  <p>The provincial government can issue permits for high-rise apartments up to 20 stories near transportation hubs, overriding municipal planning. Without considering existing city infrastructure like parking and utilities.</p>	Absent
 Bill 19 – 2020 Covid-19 Related Measures Act  <p>Enforcement legislation regarding Lock Downs, restriction of movement and control contrary to the Canadian Bill of Rights and the Charter.</p>	Voted For
